The chemical, physical, and toxicological properties have not been thoroughly investigated. Blood disorders. The Food and Drug Administration and the Center for Disease Control have established a link between I-tryptophan and a sometimes fatal blood disorder called eosinophilia-myalgia syndrome which is marked by severe muscle and joint pain, swelling of the arms and legs, skin rash, and sometimes fever. It is characterized by severe eosinophilia, a blood disorder in which the white blood cells increase to an abnormally high level. L-Tryptophan occurs naturally in many foods and investigation has not established whether it or an impurity introduced during manufacture or distribution is the cause.


